# **COURSE DESCRIPTION / OBJECTIVES**

Continued development of functional piano skills for the professional musician; independent competency at the piano for use as a tool in the chosen profession.

#### **SKILLS EMPHASIZED:**

- 1. Sightreading
- 2. Technique, especially "playing blind" with effective fingering
- 3. Accompanying
- 4. Transposition
- 5. Harmonization
- 6. Improvisation
- 7. Performing piano literature with convincing interpretation
- 8. General Musicianship as it relates to keyboard theory

### **COMPETENCIES:**

- 1. Complete units 10–18 of Alfred's Group Piano for Adults Book 1.
- 2. Demonstrate playing triads and inversions with both hands.
- 3. Demonstrate two-octave major and five-finger minor scales, hands together.
- 3. Harmonize and transpose melodies using the V(7), IV chords.
- 4. Sight-read and transpose beginner-level pieces in a variety of styles.
- 5. Improvise and embellish melodies in major and minor scales.
- 6. Play repertoire from the textbook as well as beginner-level pieces as assigned.

Each task/assignment/exam will be graded on a scale of 100 points. Each score will then be adjusted according to the percentage that it counts toward the final semester grade (see above). After I have calculated the number of points (adjusted for the above percentages), I will add all of them together to find the final percentage corresponding to your final letter-grade for the course, using the scale: A 93-100, A–90-92, B+ 87-89, B 83-86, B– 80-82, C+ 77-79, C 73-76, C– 70-72, D+ 65-69, D 60-64, F less than 60 percent. Exams will take place during class and students will sign up for individual time slots. Exams will include performance of a prepared repertoire piece, scale and chord examples, harmonization, transposition, improvisation, and sightreading.
